Furthermore, the record DFA 830 swing door operator is fully compliant with European standards and fire approved, making it ideal for creating and maintaining security, smoke and fire zones.

An entrance equipped with a record DFA 830 operator is always accessible due to battery back-up. The record DFA 830 also monitors the battery for power and function, and gives an electronic indication if it is not working properly and needs to

be replaced.

The operator is truly reliable during all weather conditions as it is not affected by stack pressure and wind load when opening and/or closing. Also, for your convenience, safety and quick exit, the record DFA 830 can easily be manually opened, despite extended closing torque, due to sensor detection ensuring lowest manual opening force.

In addition to the standard version, there is a Double Acting (DA) function with possibility for manual opening in both directions with automatic reset.


